The Benevolence Process is on page 2 of the form that explains to the applicant (member in need) the process the church takes to get their request approved. The Deacon will submit the form to the Deacon Council for approval (note: typically, this will happen during the monthly meeting but can happen via email if it is an emergency). 4.

Donors may not direct Church to allocate their contributions to be paid as benevolence to any specific individual. CRITERIA. - Key point: A church need not issue 1099 forms to benevolence recipients, since such distributions ordinarily do not represent compensation for services rendered.
- In a recent private letter ruling, the IRS concluded that a charity need not issue a 1099 form to a beneficiary of its charitable services.
